

Tolls / Road use charge, goods transport Denmark

With the exception of the following road user charges, no tax of any kind is levied on foreign-registered goods vehicles in Denmark.

Eurovignette

In the Netherlands, Belgium, Luxemburg, Denmark and Sweden, goods transport vehicles with a total weight of 12t or more are subject to a road use charge which covers the use of motorways and assimilated roads (E-roads). The rate of tax is fixed in Euros, and is readjusted to take account of fluctuations in the exchange rate.

The road use charge is differentiated not only according to the number of axles, but also according to EURO emission standards (Euro 0, Euro I, Euro II and cleaner). The tariffs are as follows:

up to 3 axles

	1 day	1 week	1 month	1 year
Euro 0	€ 8	€ 26	€ 96	€ 960
Euro I	€ 8	€ 23	€ 85	€ 850
Euro II and cleaner	€ 8	€ 20	€ 75	€ 750

4 axles or more

	1 day	1 week	1 month	1 year

Euro I	€ 8	€ 37	€ 140	€ 1400
Euro II and cleaner	€ 8	€ 33	€ 125	€ 1250

The certificate which is proof of payment may be bought at border posts, filling stations, major ferry lines etc. Certificates bought in Denmark are also valid in the Netherlands, Belgium, Luxemburg, Sweden and vice versa. Drivers who are not in possession of a valid certificate will be subject to a fine.
